

Wannon Water – Water Tower Sunset Viewing Competition

Terms and Conditions

April 2018

1. By entering into this competition, you ('Entrant') agree to be bound by these terms and conditions.
2. The Promoter is Wannon Region Water Corporation, ABN 94 007 404 851 of 25 Gateway Road, Warrnambool, Victoria, 3280.
3. Entry is open to adults aged 18 and above who reside within Wannon Water's service region and who fulfil the entry requirements. Board members, management, staff of Wannon Water and their immediate families are not eligible to win.
4. Entry into the competition is free.
5. The competition commences on Tuesday 3rd April at 4.00pm (AEST) and ends on Sunday the 8th of April 2018 at 11.59pm (AEST). All entries must be received by 11:59pm (AEST) on Sunday 8th of April 2018.
6. To enter the competition, Entrants need to: (a) go to the website www.wannonwater.com.au ; and (b) complete the "Wannon Water Sunset Contest" online form on that website, providing contact details as requested and describing in 25 words or less why they would like to watch the sun set over Warrnambool with a bird's eye view.
7. All eligible Entrants who submit the completed form and provide all requested details, including a correct email address, by 11:59pm (AEST) on Sunday 8th of April 2018 will automatically be entered into the competition.
8. The Promoter accepts no responsibility for incomplete; incorrectly submitted; delayed; misdirected; or illegible submissions. An Entrant is permitted to complete and submit the competition entry online form once. The competition is strictly one entry per person. Subsequent entries will therefore be disregarded. The Promoter has the right to remove any entries that appear to be duplicates or multiple entries from the same Entrant.
9. Judging of all eligible entries will be performed by representatives of the Promoter. The judges' decision is final.
10. Judging of eligible entries will occur on Tuesday 10th April 2018 at Wannon Water of 25 Gateway Road, Warrnambool, Vic, 3280. The Entrant with the most creative response to "Tell us in 25 words or less why you would like to watch the sun set over Warrnambool with a bird's eye view" will be deemed the winner. There will be a total of one (1) winner. The entries at the time of judging that are deemed not to have complied with these terms and conditions will be deemed invalid.
11. The prize consists of a personalised tour of the East Warrnambool Water Tower located in Tower Square off Selby Road, Warrnambool Vic 3280, for two people. The prize also includes a hamper upon arrival and a Wannon Water gift pack, with a combined value of \$200. The tour will take place at a suitable date determined by Wannon Water in consultation with the prize winner. The prize is not redeemable for cash.
